Company Offers Aftermarket Coaters, Accumulators, and Slitting and Winding Equipment

International (PTi), a leading global manufacturer of high-performance sheet extrusion machinery, has expanded its Customer Services initiative by providing a broader range of services and a new aftermarket product line which includes coaters, accumulators, and slitting and winding equipment. "Further, PTi sees additional market opportunities through our new aftermarket offering of coaters, accumulators, slitters, and winders that complement the balance of our sheet extrusion products, but also offer our customers retrofit upgrades for aged lines."

PTi has offered these products on its new sheet extrusion machinery but this is the first time the company will offer them as stand-alone products for upgrades or retrofits of existing PTi machinery or competitive extrusion systems.

As part of the customer service realignment, PTi named J.R. Duff to the newly created post of Director of Customer Services. The company also promoted Gloria Navarro to Supervisor within the group and Scott Stecker continues to serve as Service Manager.

"The new Customer Services group at PTi provides our customers with professional and responsive field service, spare parts service, and warranty support to maximize up time for all PTi related extrusion machinery products," said Duff. In addition to providing mechanical installation services for complete new extrusion systems along with new stand-alone coating stations, winders, and slitters, PTi's Customer Services group offers machinery rebuilding/remanufacturing services, modifications, and upgrade kits; laser bore barrel alignment and wear measurement reports; replacement barrel sales and installation services; and routine maintenance repairs/replacements. Other key services include process engineering support for startups, operator training, and motor and drive controller sales and services. PTi also provides custom process and training programs at its demonstration center in Aurora or the customer's production floor, and electrical controls related services for the TITAN PLC machine controls platform.
